### Terms and Conditions

REQUIREMENTS ARE AS FOLLOWS:

SURETY BOND - \$2,500

PLUMBING - NO BOND REQUIRED WITH CURRENT STATE LICENSE

A certificate of insurance (personal injury minimum \$100,000 and property damage minimum \$50,000) listing the Village of Riverdale as the certificate holder must accompany all applications. All documents must have corresponding/matching addresses. No PO boxes are permitted.

Electricians must provide a copy of your current electrical license in another city or state.

Plumbers and roofers must provide a copy of your current state license.

I understand the issuance of this registration is conditioned upon compliance with all village ordinances/inspections. No work may commence until registration is issued and permits for each job.

I also understand that is my responsibility to ensure that all subcontractors hired by my company are registered with the Village of Riverdale.

## INSTRUCTIONS

All contractors must secure a registration **before** beginning any work in the Village of Riverdale. Checks are to be made payable to the VILLAGE OF RIVERDALE. Actual registrations will be mailed within 2 to 3 weeks after payment is made and all other required documents are received. (See other side for requirements.)

### **CONTRACTORS' REGISTRATIONS ARE ISSUED ANNUALLY MAY 1 THROUGH APRIL 30.**

All work performed on site shall be subject to inspections by duly authorized personnel of the Village of Riverdale through the Riverdale Fire-Rescue Department: Inspectional Services Division. Prior to performing work on site, check with the Riverdale Fire-Rescue Department: Inspectional Services, (708-849-1798) regarding the need to secure a permit. **ALL PERMITS MUST BE ISSUED BEFORE THE START OF ANY WORK.**
